Official Rules

CONTEST ENTRY IS VOID IF NOT ALLOWED BY LAW IN YOUR HOME JURISDICTION. ENTRY IS BASED ON ELIGIBILITY AT TIME OF PRIZE DRAW.

1. Sponsor

2. Eligibility

WordCamp Europe, Newfold Giveaway (the "Giveaway") is open to legal residents of countries that are not on the United States Trade Sanctions list who are at least eighteen (18) years old at the time of entry. Notwithstanding the foregoing, the Giveaway is also not open to residents of the Russian Federation.

THE GIVEAWAY IS VOID WHERE PROHIBITED BY LAW OR OTHERWISE.

By participating in this Giveaway, you represent and warrant that you meet the eligibility requirements, and the Giveaway is not prohibited or conditioned in your jurisdiction. Proof of residency and age may be required. Employees of Sponsor and each of its respective parent companies, subsidiaries, and affiliates and each of their Immediate Family Members (as defined below) and Household Members (as defined below) are not eligible to enter or win. "Immediate Family Members" shall mean parents, stepparents, children, stepchildren, siblings, step siblings, or spouses, regardless of where they live. "Household Members" shall mean people who share the same residence at least three (3) months a year, whether related or not. To enter the Giveaway or receive a prize, you must fully comply with these Official Rules and, by entering, you represent and warrant that you agree to be bound by these Official Rules and the decisions of Sponsor, which shall be binding and final in all respects to this Giveaway. Sponsor may disqualify in its sole discretion, any entrant who is under a third-party agreement which Sponsor deems as contradictory to the amateur nature of this Giveaway.

3. Timing

The Giveaway begins on June 9, 2023, at 8:30 A.M. GMT +3 (Eastern European Summer Time) and ends on June 10, 2023 at 1:45 P.M. GMT +3, (“Giveaway Entry Period”). Sponsor is the official timekeeper for this Giveaway. The

Giveaway is governed by these Official Rules and is subject to all applicable federal, state, and local laws.

4. How to Enter

You can enter the Giveaway by collecting tickets. You are eligible to collect a ticket when a Bluehost or Yoast representative sees that you have Bluehost, Yoast, and YITH pins visible. To receive a branded pin, you must complete an activity at each of the respective sponsor booths of Bluehost, Yoast, and YITH.

There is no limit of entries, however ticket disbursement is at the sole discretion of representatives of Bluehost and/or Yoast and/or YITH. Any attempt by you to obtain more than the stated number of entries by using multiple/different identities, registrations and logins, or any other methods will be void and you and your entries will be disqualified. Use of any automated system to enter is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, or misdirected entries, all of which will be ineligible to win a prize. In the event of a dispute as to any entrant, the authorized account holder of the ticket used to enter will be deemed to be the entrant. The “authorized account holder” is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. A. Must be a registered attendee for WordCamp Europe, 2023, always displaying the provided name-badge.

B. Must be present to win at time of drawing, which will be at the Bluehost booth around 1:45 pm (GMT+3, Eastern European Summer Time) on June 10, 2023.

6. Grant of Rights

By entering the Giveaway, you grant to Sponsor the worldwide, irrevocable and unrestricted right and license to adapt, publish, use, edit, and/or modify your entry in any way and to post your response on the internet.

7. Representations and Warranties

Each person who enters this Giveaway represents and warrants as follows: (i) the entry content is wholly original to entrant; (ii) the entry does not and will not violate or infringe upon the intellectual property rights or other rights of any other person or entity; and (iii) the entry does not and will not violate any applicable laws and is not and will not be considered defamatory or libelous.

8. Winners Determination

On June 10th, 2023, at the Bluehost WordCamp Europe booth, the sponsor will select three (3) potential winners in a random drawing through random selection via blind draw of tickets, of all valid entries received during the Giveaway Entry Period. The potential Giveaway winners must be present to win and will be validated on the spot and may be awarded the prize subject to verification of eligibility and compliance with the terms of these Official Rules. The potential Giveaway winner will be notified on the day of the drawing. Failure by a potential Giveaway winner to claim that their ticket was pulled within ten to fifteen (10-15) seconds, will result in disqualification and Sponsor will select an alternate potential Giveaway winner in the same manner. Odds of winning a Giveaway prize depend on the number of eligible entries received.
